Digital Television Installation Agreement

This contract with Gorham Telephone Company and Gorham Communications, Inc. must be completed prior to technician installation. You will be billed monthly for all services. Prices of regulated telecommunications services are set by tariff and are subject to change by regulatory agencies. Television prices are subject to change due to network price increases. Discounts for packages are applied to prices of the unregulated services. A deposit may be required. Disconnection of regulated telecommunications services for nonpayment is subject to state-approved procedures. Partial payment will be applied first to those regulated services. Some restrictions or other conditions may apply.

I hereby authorize Gorham Telephone Company and Gorham Communications, Inc. their personnel and/or contractors to work on my existing wiring and outlets to connect digital television service. I understand I am responsible for disconnecting any existing television services with any current provider other than Gorham Communications, Inc. If additional equipment is needed to receive service, I may be charged for the labor and parts involved. I have been advised not to disconnect current service until the installation of Gorham Telephone Company and Gorham Communications, Inc. digital services are installed and operational.

I am aware that Gorham Telephone Company and Gorham Communications, Inc. retain ownership of the television set top box, remote control and modem. I understand that if a set top box, remote control or modem is stolen, lost or damaged, I will be charged the replacement value of the equipment on my telephone bill. Damaged remotes may be replaced for a \$25.00 charge. I am also aware that I will be charged any installation fees that were waived at the time of installation, if service is part of an annual or multi-year contract and is terminated early. Some restrictions or other conditions may apply.
